READING OF THE MISSION

Mr. Kunselman read the following School District Mission Statement:

PSERS UPDATE PRESENTATION

Jeffrey Clay, Executive Director of the Pennsylvania School Employees' Retirement System (PSERS), shared a PowerPoint presentation regarding the rate spike and plateau, which directly and indirectly impacts school districts' and the state's finances. He presented an overview of PSERS, which is a defined benefit pension plan for Pennsylvania school employees established in 1917. Mr. Clay shared information regarding the ten year history of member and employer contributions and investment earnings, net plan assets from 2002 through 2009, historic returns of stocks, bonds, and t-bills, investment rates of return, employer contribution rates, options to fix the rate spike, the Governor's proposal, projections showing an alternative proposal, and conclusions.

GUIDELINES FOR RESIDENTS' COMMENTS

The Upper St. Clair School Board encourages USC residents and/or taxpayers (hereafter referred to as "Residents") to give comments at public meetings of the Board and its committees. Residents' comments reflect only the views and opinions of the speakers and not those of the School Board. Individual speakers are responsible for the accuracy of all information presented.

In order that the Board can effectively conduct its business, Residents are asked to abide by the following guidelines:

- 1. Residents' comments will be heard twice during each meeting: at the beginning of the meeting following any special recognitions, and at the end of the meeting.
- 2. Comments shall be limited to three (3) minutes in length. If a Resident desires to speak longer than three minutes, prior to commencing his or her comments, he or she may ask the Chair's permission to do so.
- 3. Comments at the beginning of the meeting shall be limited to items that appear on the agenda. Residents wanting to make a comment at the beginning of the meeting are asked to sign in at the Welcome Table, prior to the beginning of the meeting, indicating the agenda item to be addressed.
- 4. At the end of the meeting, prior to adjournment, the Board will hear all comments by any Resident wishing to speak pertaining to any item relevant to the School District.
- 5. Residents must give their name and street address at the beginning of their comments.
- 6. Residents are asked to be respectful and factual in their comments.
- 7. If a Resident desires to distribute materials to all Board members, they are encouraged to provide enough copies for all nine members. If a Resident requests the District to make copies of materials, a cost of \$.25 per page will be charged for this service, as outlined in Policy #7013 Public Records.
- 8. Board members are encouraged to remain in attendance at the meeting until all comments have been heard. Board members will continue the practice of not responding to Residents' comments.

These guidelines may be modified by the meeting Chair, depending on the circumstances of any particular meeting. The Chair may limit the length of individual comments, or the total number of comments heard, depending on the length of the agenda for that night, and the number of speakers.

A Resolution Urging Legislative Action on School Employee Pension Reform By the Board of School Directors for the Upper St. Clair School District

WHEREAS, school districts in Pennsylvania are required to participate in a statewide pension program administered by the Board of Directors of the Pennsylvania Public School Employees Retirement System ("PSERS"); and

WHEREAS, in December 2009 the PSERS Board voted to increase the employer contribution to the system for the 2010-11 school year to 8.22%, a 72% increase over the 2009-10 rate; and

WHEREAS, the employer contribution rate is projected to increase sharply in the next four years, reaching a peak of 33.60% in the 2014-15 school year; and

WHEREAS, the employer contribution rate is projected to remain over 30% until the year 2020, over 25% until the year 2027 and over 20% until the year 2032; and

WHEREAS, both the Upper St. Clair School District and the Commonwealth of Pennsylvania are responsible for paying a portion of the employer's share; and

WHEREAS, the projected increases in employer contribution are significant and present critical problems that effectively force the addition of higher financial burdens on taxpayers, school districts and the Commonwealth and consequently demand both a short-term and a long-term solution; and

WHEREAS, a meaningful solution to these problems must involve the identification of another funding source for PSERS, decreasing or cutting the costs/liabilities of the system, including benefit levels, and deferring the system's liabilities.

NOW, THEREFORE, BE IT RESOLVED, that the Upper St. Clair Board of School Directors makes the following recommendation:

- 1. The General Assembly begin immediate consideration of school employee pension reform with the dual purpose of reducing projected employer contribution rate increases over the next four years and reducing projected costs to school districts, taxpayers, and the Commonwealth over the next two decades, while maintaining an appropriate pension benefit for school employees;
- 2. As a result of the projected employer contribution rate increases, the General Assembly consider immediate amendments to the Public School Employees' Retirement Code to include limits on eligibility, funding levels, benefits as well as any hybrid benefit plans and new or alternative sources of state revenue independent of the school district contribution rate; and
- 3. The General Assembly recognize that permitting the employer contribution rate to spike to the current projected levels would adversely impact every school district in the Commonwealth of Pennsylvania from providing the constitutional mandate of a thorough and efficient education for district students.


